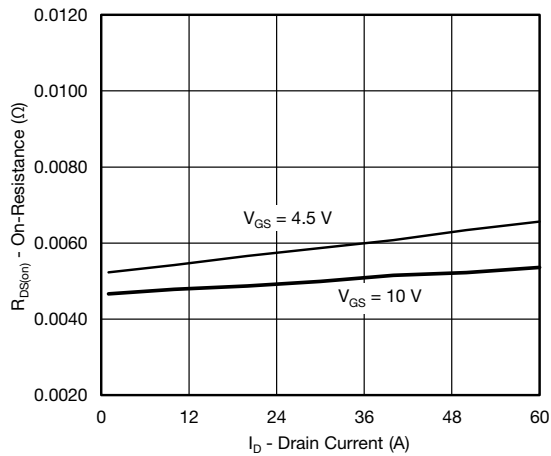

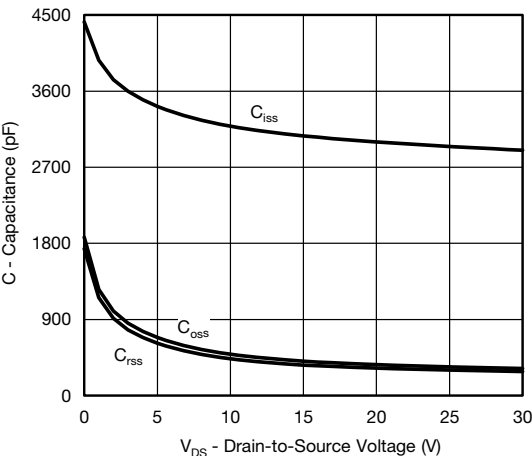

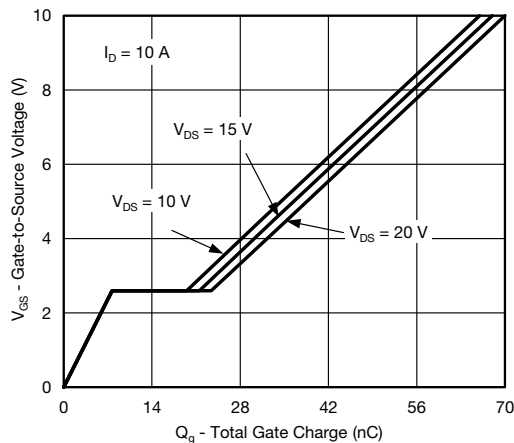

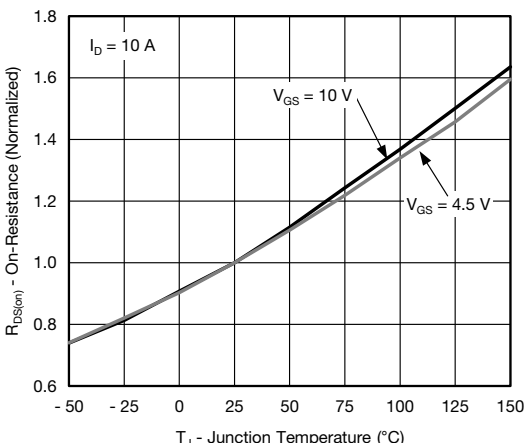
On-Resistance vs. Drain Current and Gate Voltage

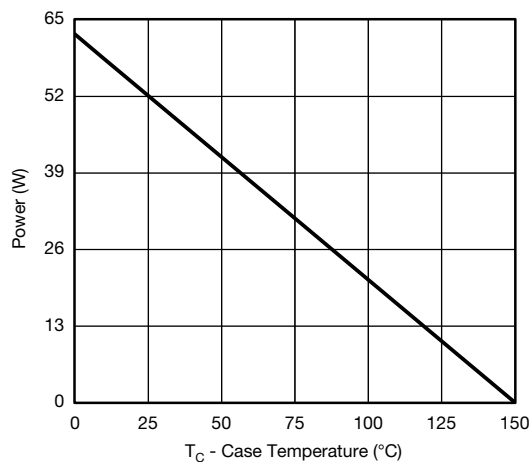

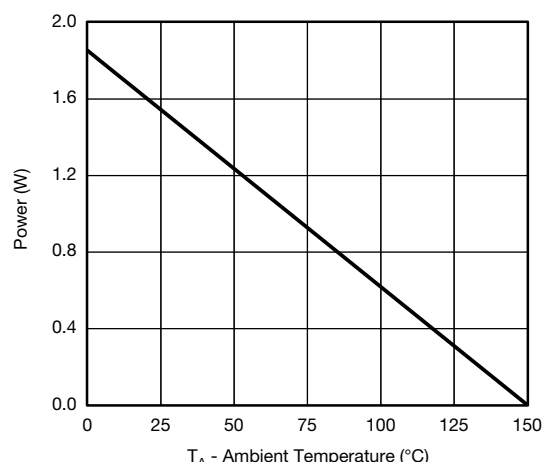

Current Derating*



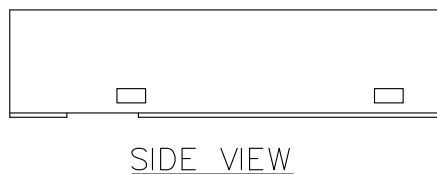
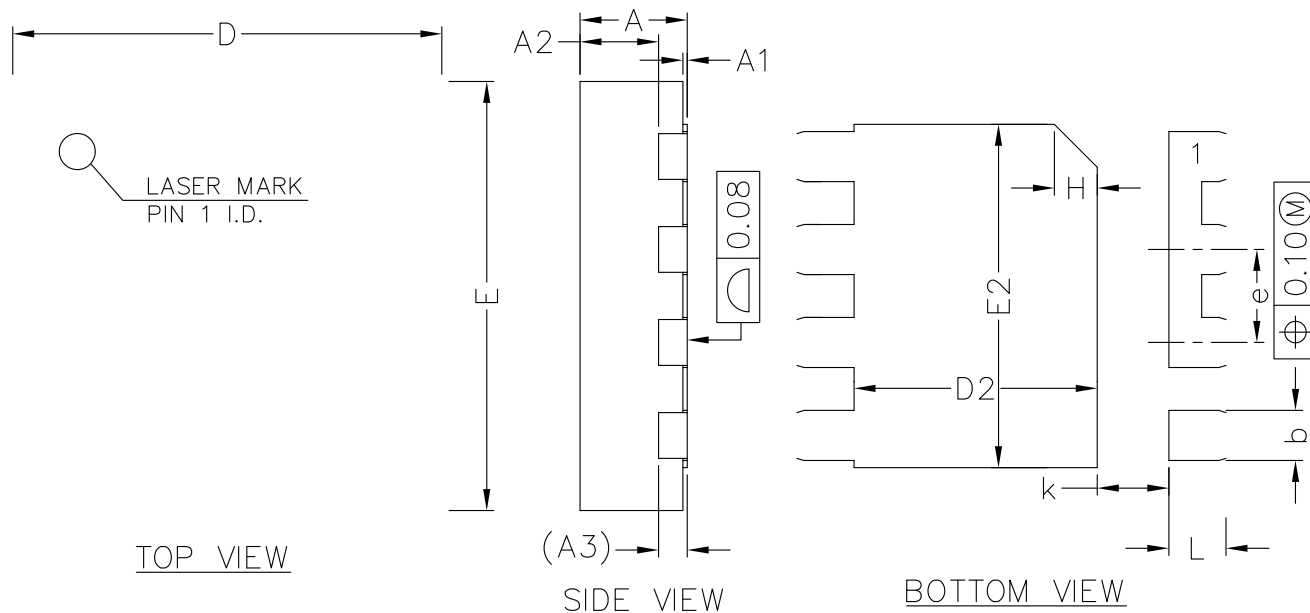
Power, Junction-to-Case
