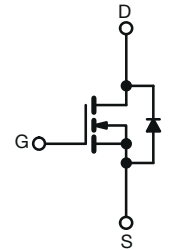

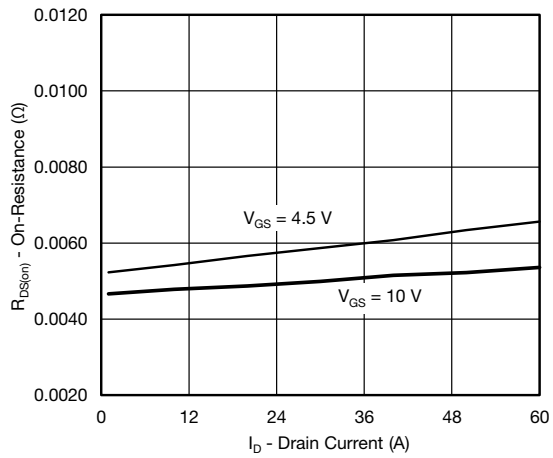

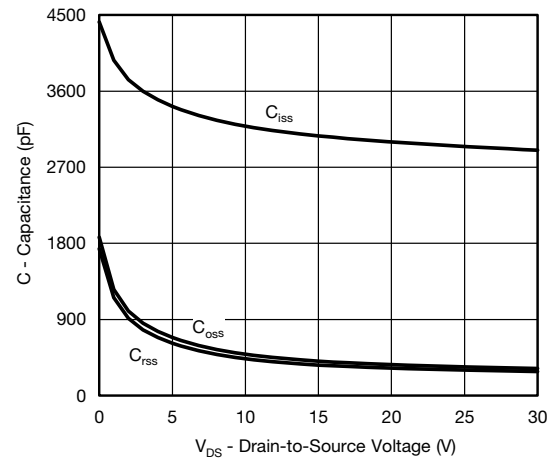

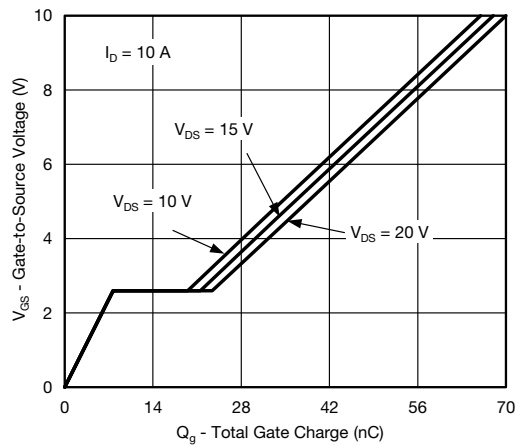

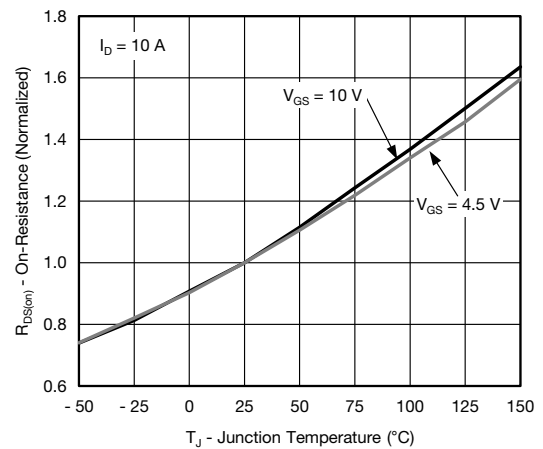
On-Resistance vs. Drain Current and Gate Voltage

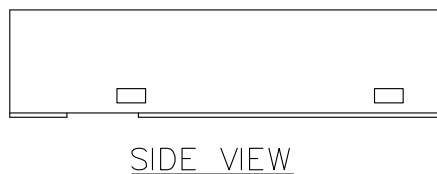
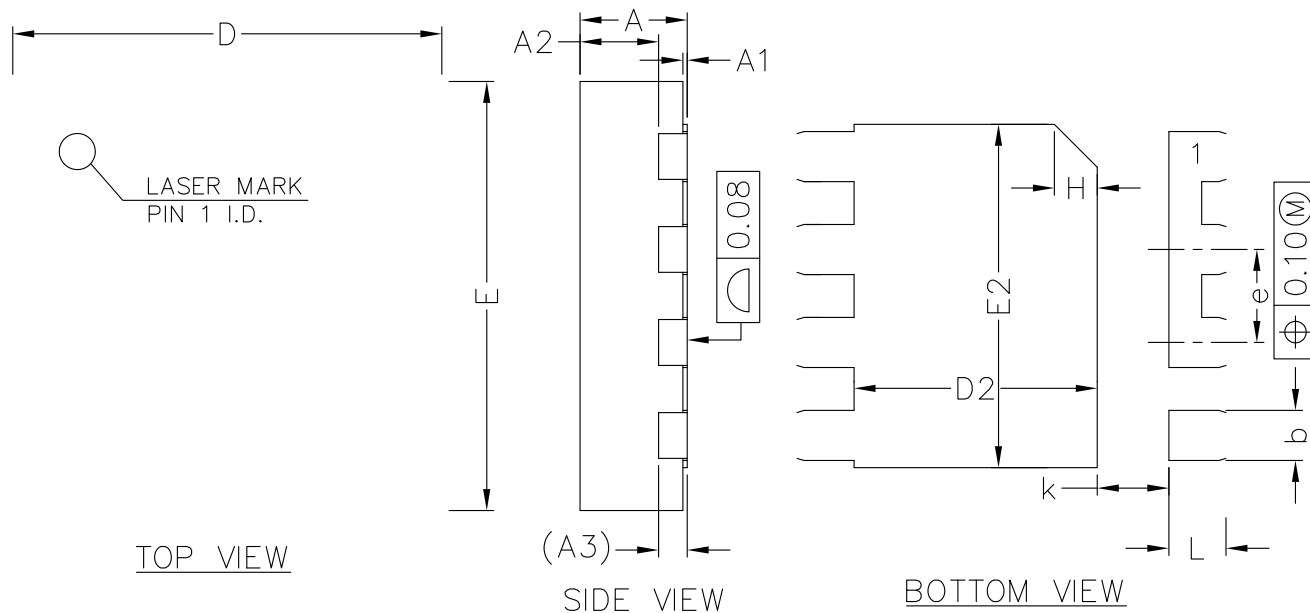


Safe Operating Area, Junction-to-Ambient
