
On-Resistance vs. Drain Current and Gate Voltage



 $V_{\mbox{GS}}$ - Gate-to-Source Voltage (V)





Capacitance



On-Resistance vs. Junction Temperature









Source-Drain Diode Forward Voltage








Threshold Voltage










