






 $\mathsf{R}_{\mathsf{DS}(\mathsf{on})}$ - On-Resistance (Ω)


 $V_{\mbox{GS}}$ - Gate-to-Source Voltage (V)

On-Resistance vs. Gate-to-Source Voltage











TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted
