
#### TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)













R<sub>DS(on)</sub> vs. V<sub>GS</sub> vs. Temperature




Forward Diode Voltage vs. Temperature


























<u>VIEW 'A'</u> (SCALE 5:1)
