


Transconductance



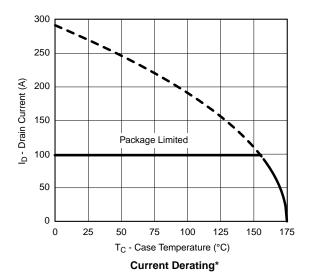



R<sub>DS(on)</sub> vs. Drain Current









Normalized Thermal Transient Impedance, Junction-to-Case




DFN5x6\_8L\_EP1\_P PACKAGE OUTLIN










<u>VIEW 'A'</u> (SCALE 5:1)
