






R_{DS(on)} vs. Drain Current








On-Resistance vs. Junction Temperature




 V_{GS} - Gate-to-Source Voltage (V) $R_{DS(on)}\, vs.\, V_{GS}\, vs.\, Temperature$



Forward Diode Voltage vs. Temperature








Safe Operating Area, Junction-to-Ambient







Normalized Thermal Transient Impedance, Junction-to-Case




