


TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)






TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)




 V_{GS} - Gate-to-Source Voltage (V) R_{DS(on)} vs. V_{GS} vs. Temperature




Forward Diode Voltage vs. Temperature



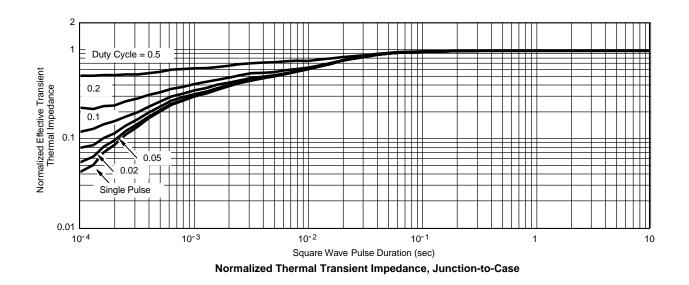
















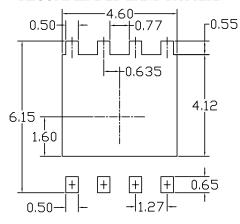






<u>VIEW 'A'</u> (SCALE 5:1)
