




 $R_{\text{DS(on)}}$ vs. V_{GS} vs. Temperature




Forward Diode Voltage vs. Temperature



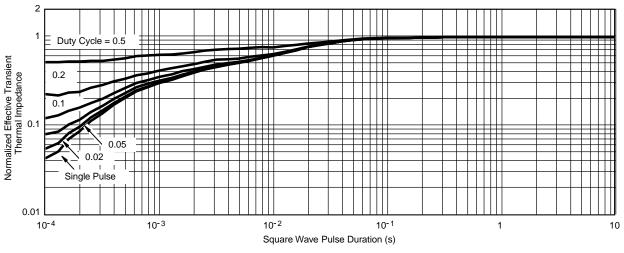












Normalized Thermal Transient Impedance, Junction-to-Case


