





TYPICAL CHARACTERISTICS (25 °C, unless otherwise noted)













 $R_{\text{DS(on)}}$ vs. V_{GS} vs. Temperature








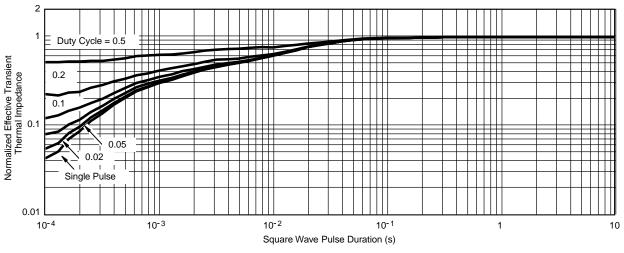












Normalized Thermal Transient Impedance, Junction-to-Case
