







Transconductance







R_{DS(on)} vs. Drain Current







Threshold Voltage









Normalized Thermal Transient Impedance, Junction-to-Case



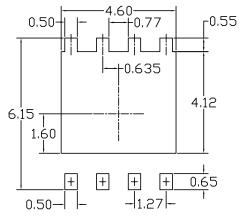
