




Transconductance






 $R_{DS(on)}$ vs. Drain Current









On-Resistance vs. Junction Temperature




 $R_{DS(on)}$ vs. V_{GS} vs. Temperature



Forward Diode Voltage vs. Temperature








Safe Operating Area, Junction-to-Ambient







Normalized Thermal Transient Impedance, Junction-to-Case




DFN5x6_8L_EP1_P PACKAGE OUTLIN










<u>VIEW 'A'</u> (SCALE 5:1)
