







#### Normalized On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient

Threshold Voltage







Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot


