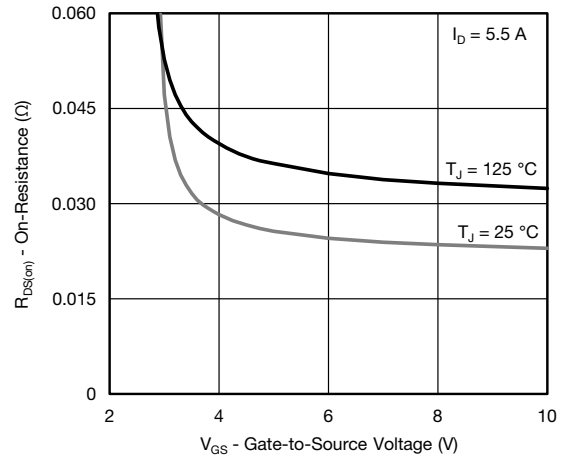

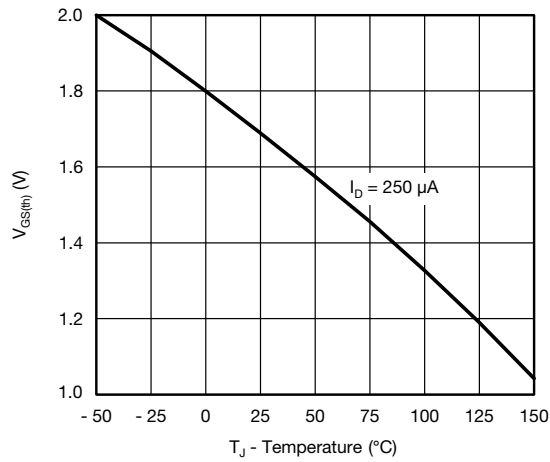

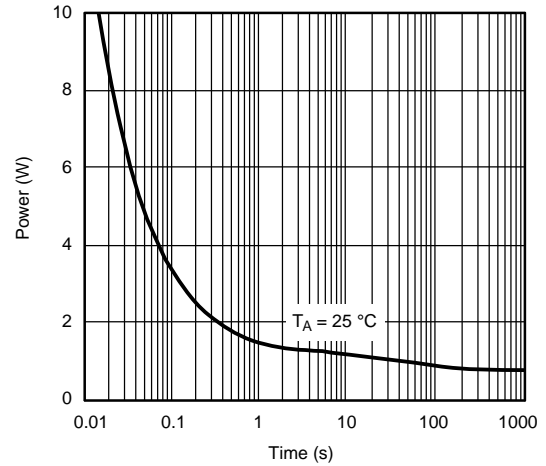
Source-Drain Diode Forward Voltage



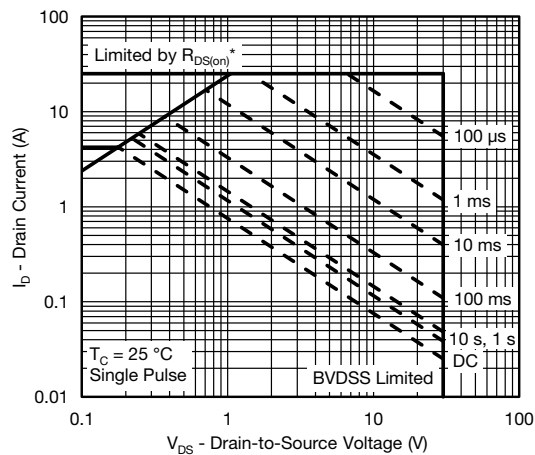
On-Resistance vs. Gate-to-Source Voltage



Threshold Voltage



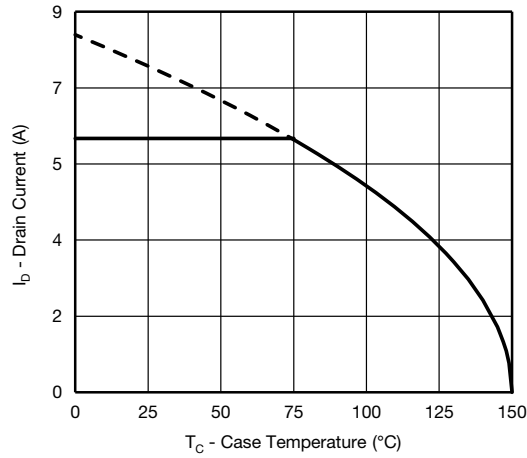
Single Pulse Power (Junction-to-Ambient)

Safe Operating Area, Junction-to-Ambient

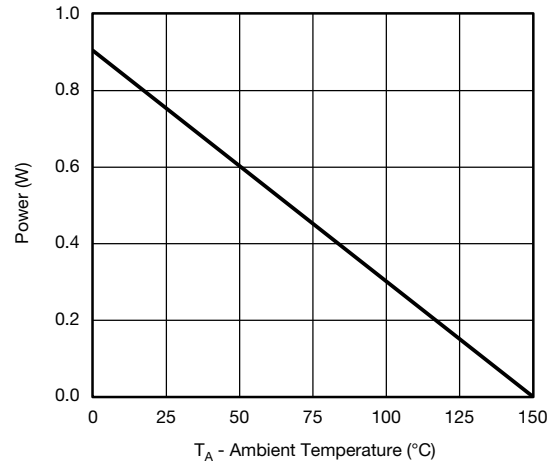

Current Derating*

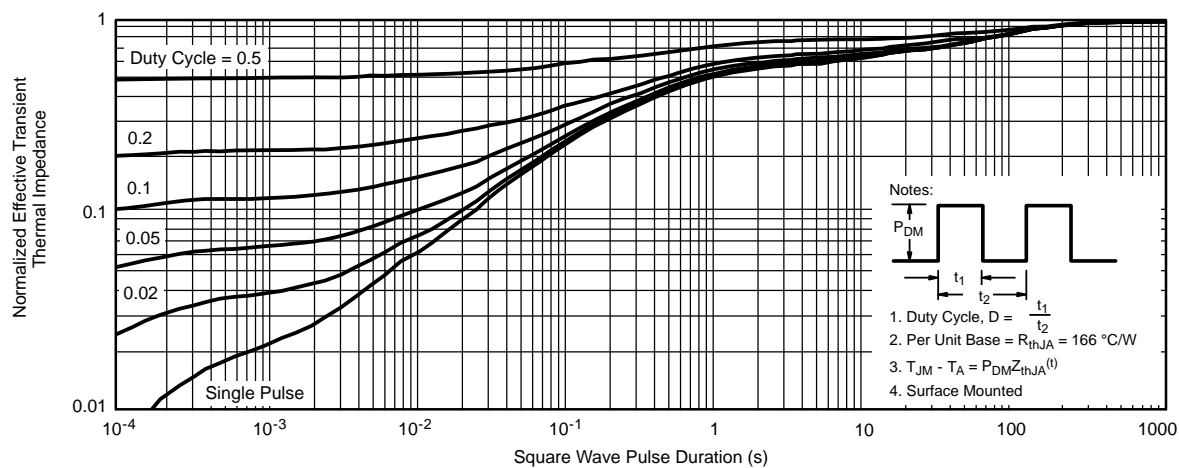


Power Derating, Junction-to-Foot



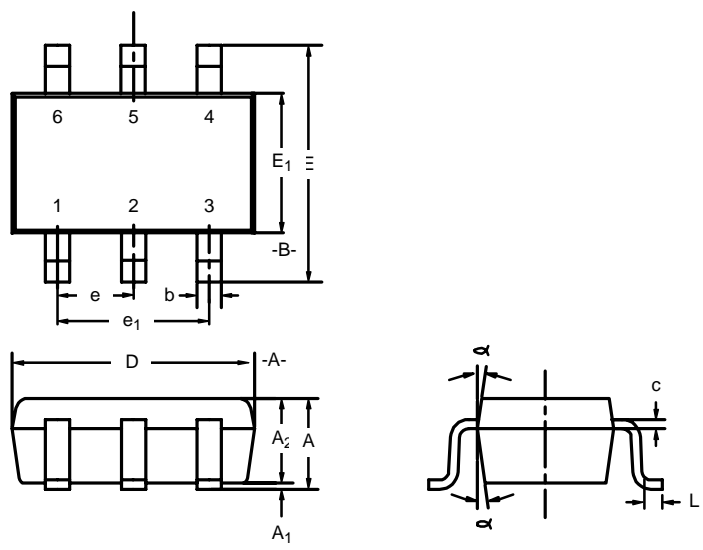
