


#### Gate Current vs. Gate-to-Source Voltage






On-Resistance vs. Drain Current



Gate Current vs. Gate-to-Source Voltage





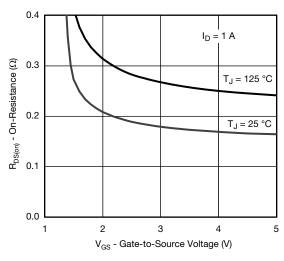




#### On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient

#### Threshold Voltage







#### Current Derating\*












Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot
