


N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted












Source-Drain Diode Forward Voltage










Normalized Thermal Transient Impedance, Junction-to-Ambient




N-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Foot

P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






P-CHANNEL TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted
