









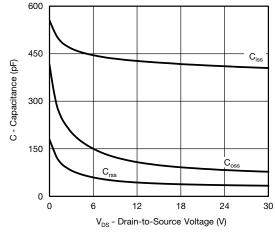


On-Resistance vs. Drain Current and Gate Voltage






Transfer Characteristics








On-Resistance vs. Junction Temperature

 V_{DS} - Drain-to-Source Voltage (V) * V_{GS} > minimum V_{GS} at which $R_{DS(on)}$ is specified




