







Source-Drain Diode Forward Voltage








Threshold Voltage





Safe Operating Area








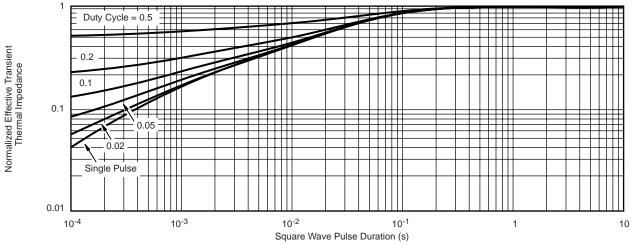
