










Source-Drain Diode Forward Voltage




Threshold Voltage



On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power








T_C - Case Temperature (°C)

Current Derating*














Normalized Thermal Transient Impedance, Junction-to-Foot


