










#### Source-Drain Diode Forward Voltage




## **Threshold Voltage**



On-Resistance vs. Gate-to-Source Voltage












T<sub>C</sub> - Case Temperature (°C)







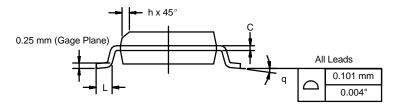
Normalized Thermal Transient Impedance, Junction-to-Foot


