














Threshold Voltage

Single Pulse Power, Junction-to-Ambient





T_C - Case Temperature (°C) Current Derating*







Normalized Thermal Transient Impedance, Junction-to-Ambient

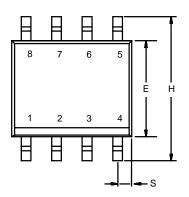


Normalized Thermal Transient Impedance, Junction-to-Foot


