
On-Resistance vs. Drain Current and Gate Voltage



V_{GS} - Gate-to-Source Voltage (V) **Transfer Characteristics**





 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:VDS} \mbox{\bf Capacitance}$




 $\label{eq:TJ-Junction} T_{J} \text{ - Junction Temperature (°C)}$ On-Resistance vs. Junction Temperature








Source-Drain Diode Forward Voltage




On-Resistance vs. Gate-to-Source Voltage



Threshold Voltage






Safe Operating Area, Junction-to-Ambient







Power Derating, Junction-to-Foot






Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot


