








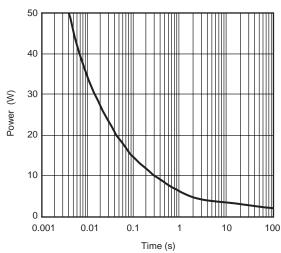


Source-Drain Diode Forward Voltage




V_{GS} - Gate-to-Source Voltage (V)

Single Pulse Power, Junction-to-Ambient








T_C - Case Temperature (°C)

Current Derating*




Power, Junction-to-Foot






