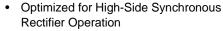



Operating Junction and Storage Temperature Range





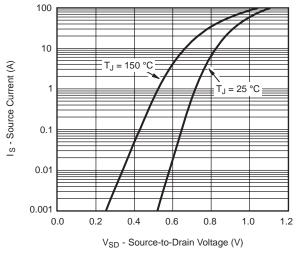









Source-Drain Diode Forward Voltage



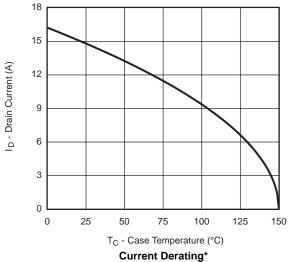
Single Pulse Power, Junction-to-Ambient










Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot

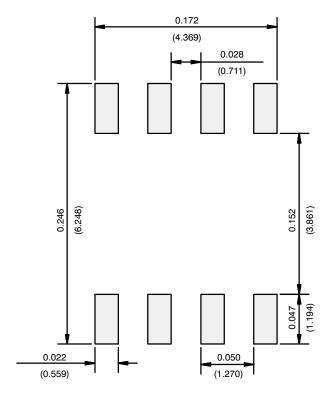
