










#### Source-Drain Diode Forward Voltage





 $V_{GS}$  - Gate-to-Source Voltage (V) On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient





#### Current Derating\*







Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot


