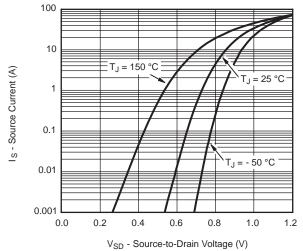

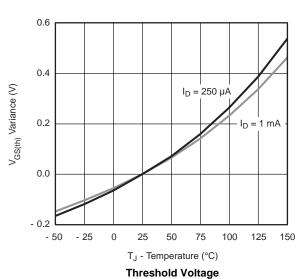




#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

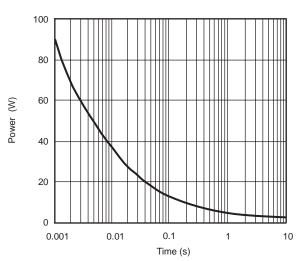

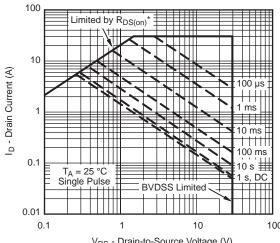

Single Pulse Power, Junction-to-Ambient



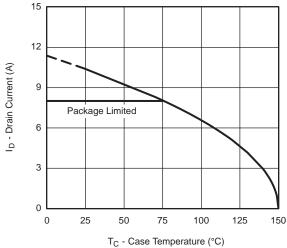
V<sub>DS</sub> - Drain-to-Source Voltage (V)

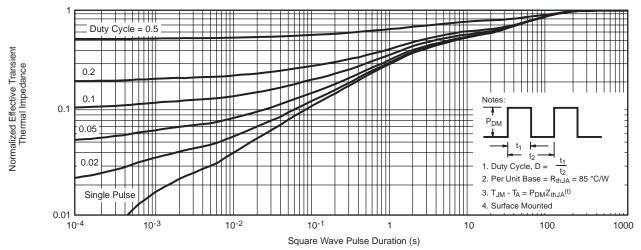

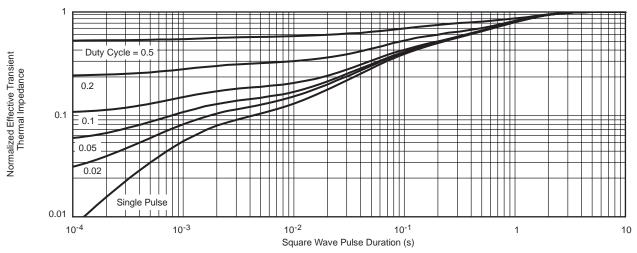
