


TYPICAL CHARACTERISTICS 25 C, unless otherwise noted




T_J - Junction Temperature (°C) On-Resistance vs. Junction Temperature







TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted



On-Resistance vs. Gate-to-Source Voltage












TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Foot


