

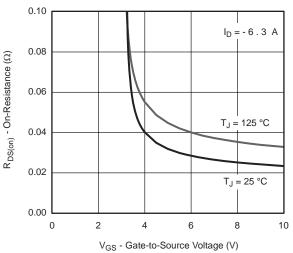







I<sub>D</sub> - Drain Current (A)





### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Foot


