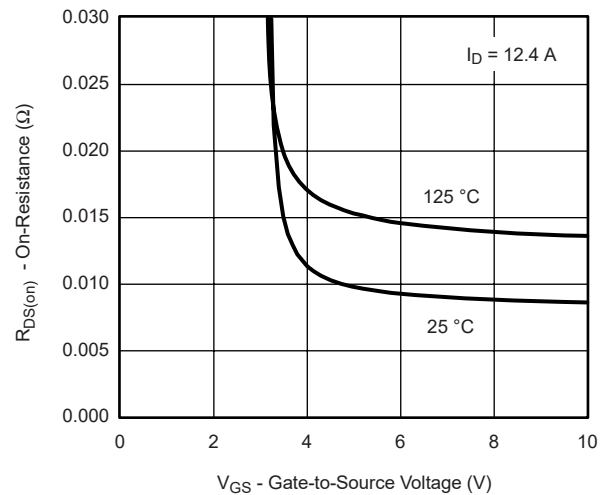

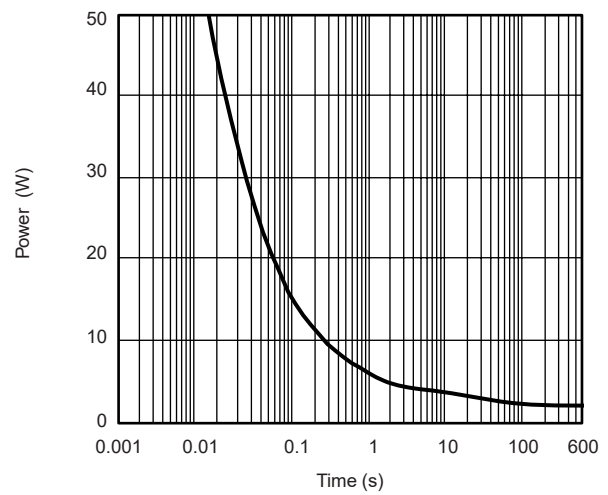
Source-Drain Diode Forward Voltage

Threshold Voltage



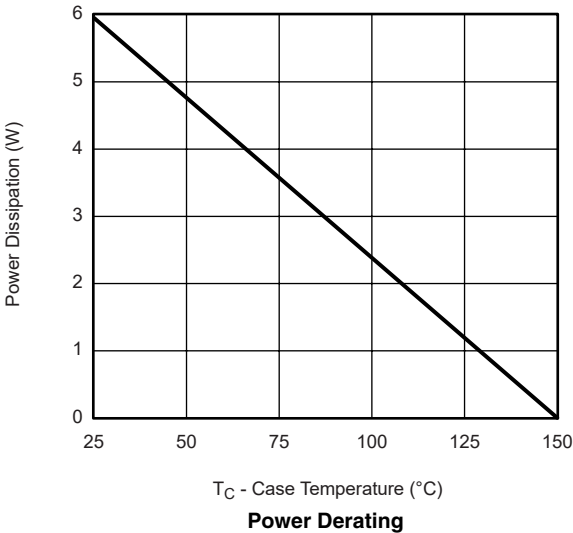
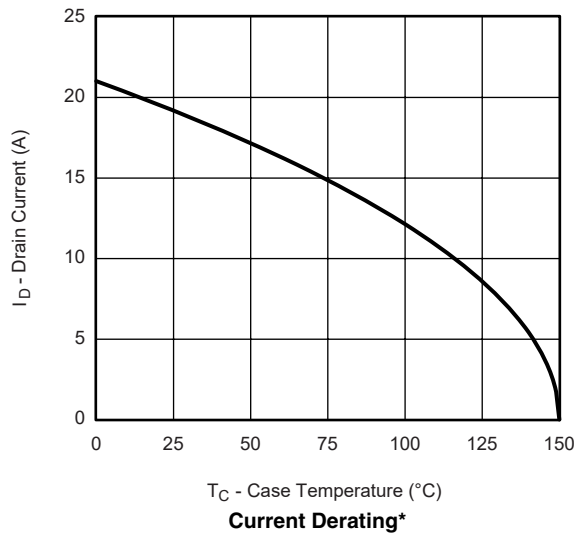
Single Pulse Power (Junction-to-Ambient)

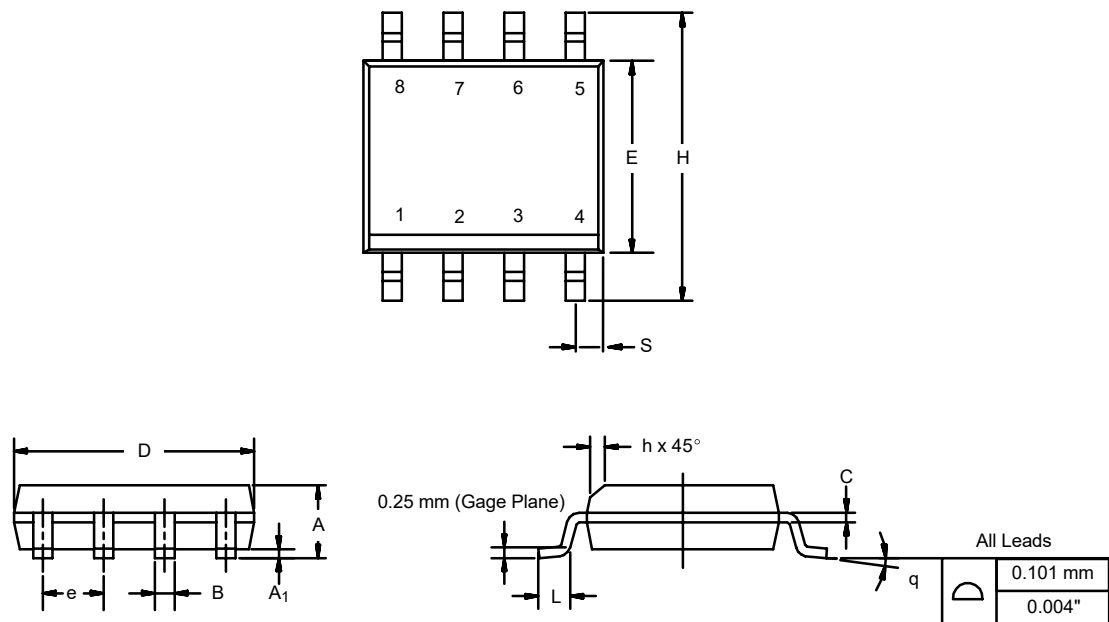
