










Source-Drain Diode Forward Voltage




Threshold Voltage



 V_{GS} - Gate-to-Source Voltage (V) On-Resistance vs. Gate-to-Source Voltage



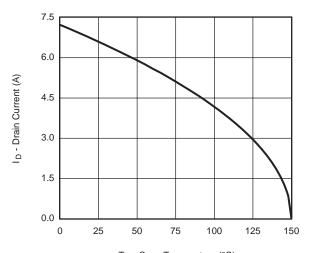
Single Pulse Power


Safe Operating Area, Junction-to-Ambient






T_C - Case Temperature (°C)

Power, Junction-to-Foot




T_A - Ambient Temperature (°C)




Normalized Thermal Transient Impedance, Junction-to-Ambient

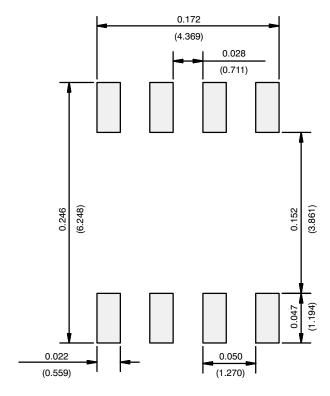
