 $I_D = 8 A$







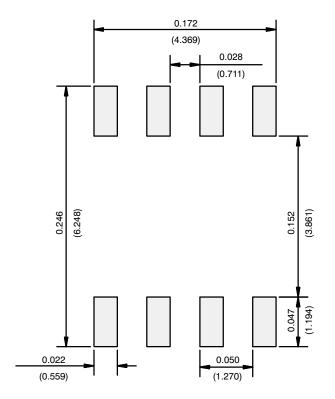
