










Gate Current vs. Gate-Source Voltage



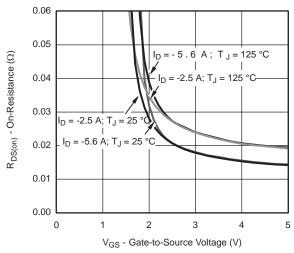







On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage




Single Pulse Power, Junction-to-Ambient



Soure-Drain Diode Forward Voltage











