


On-Resistance vs. Drain Current and Gate Voltage




 $V_{\mbox{GS}}$ - Gate-to-Source Voltage (V)







Source-Drain Diode Forward Voltage

On-Resistance vs. Gate-to-Source Voltage



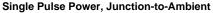


Safe Operating Area, Junction-to-Ambient




Power Derating, Junction-to-Foot Power Derating, Junction-to-Ambient


Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot


