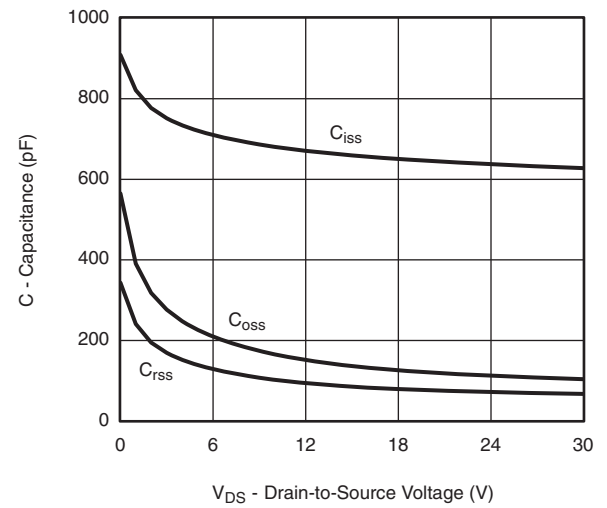

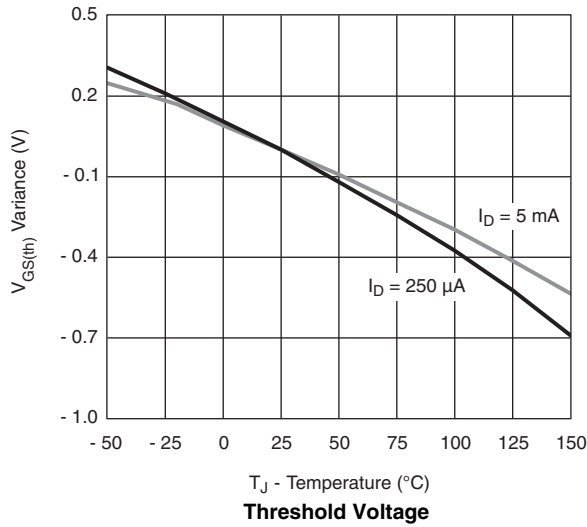

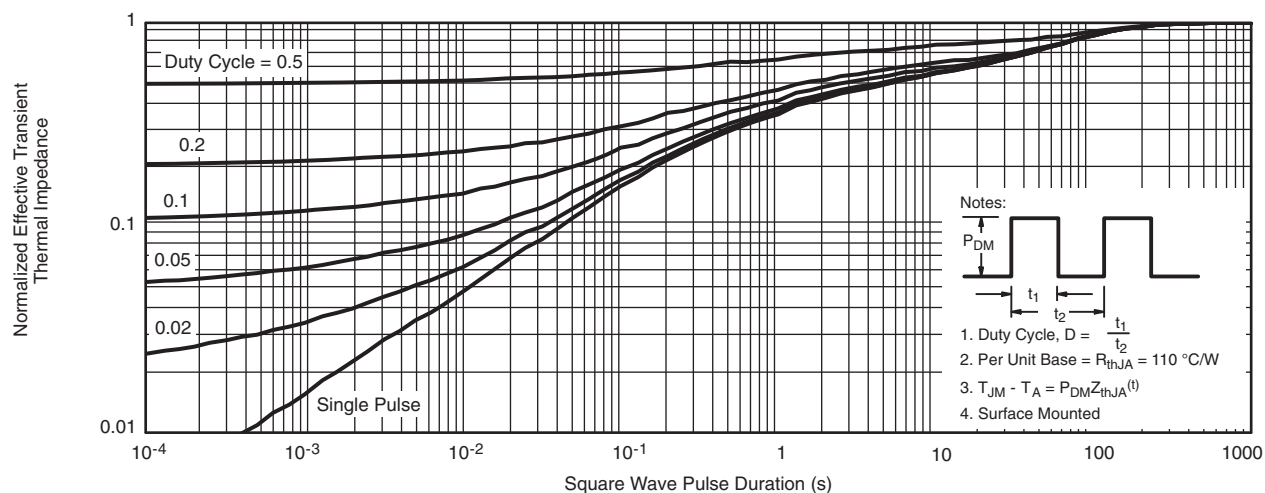
**Power Derating, Junction-to-Foot**



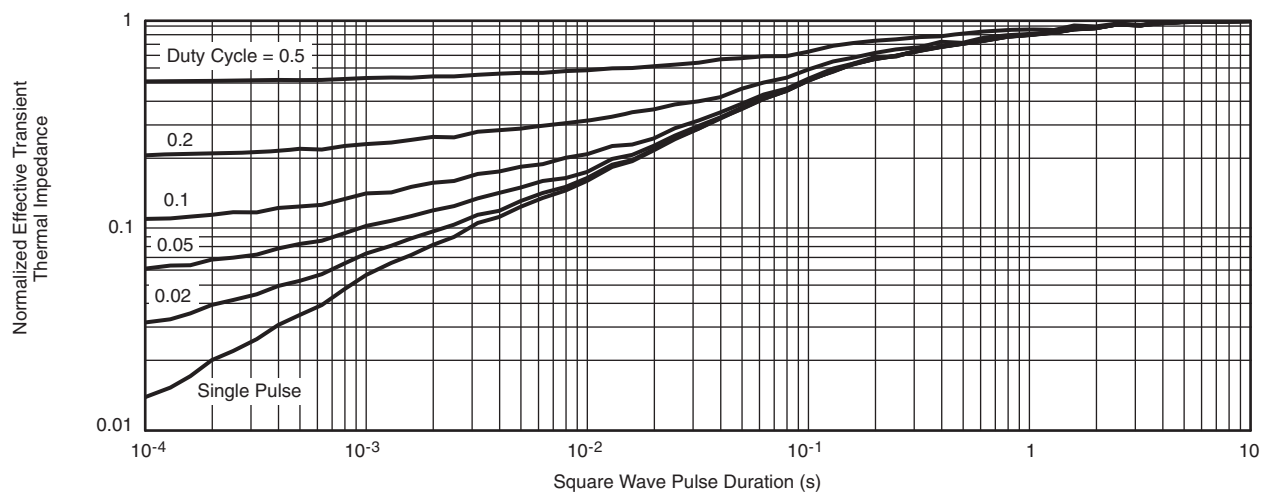
