



I<sub>D</sub> - Drain Current (A) On-Resistance vs. Drain Current and Gate Voltage

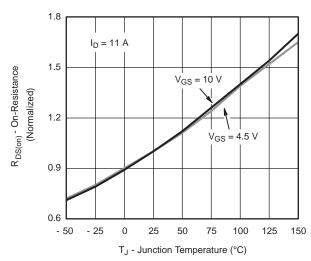

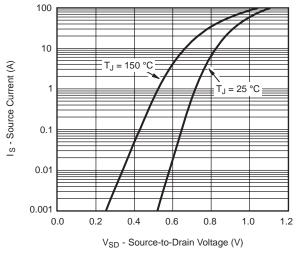




On-Resistance vs. Junction Temperature







#### Source-Drain Diode Forward Voltage

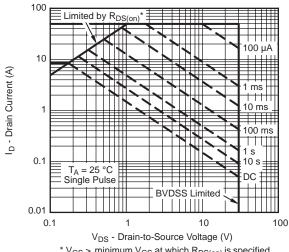


On-Resistance vs. Gate-to-Source Voltage





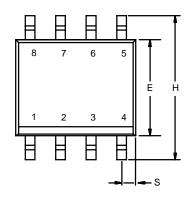
#### Normalized Thermal Transient Impedance, Junction-to-Ambient




Normalized Thermal Transient Impedance, Junction-to-Foot

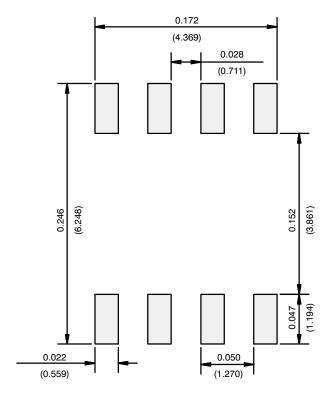
