
#### On-Resistance vs. Drain Current and Gate Voltage



V<sub>GS</sub> - Gate-to-Source Voltage (V) **Transfer Characteristics** 









On-Resistance vs. Junction Temperature











On-Resistance vs. Gate-to-Source Voltage



**Threshold Voltage** 




Single Pulse Power, Junction-to-Ambient







