








#### Source-Drain Diode Forward Voltage




Threshold Voltage

Single Pulse Power, Junction-to-Ambient








 $T_{\mbox{\scriptsize C}}$  - Case Temperature (°C)









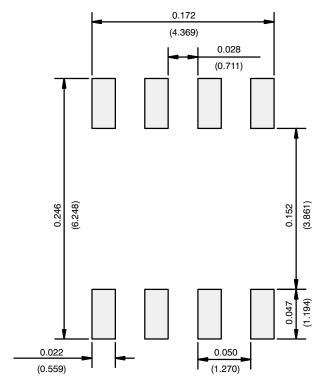
