




TYPICAL CHARACTERISTICS 25 °C unless otherwise noted



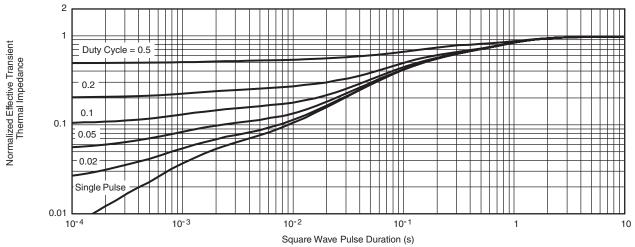






Normalized Thermal Transient Impedance, Junction-to-Foot


