


**On-Resistance vs. Junction Temperature** 



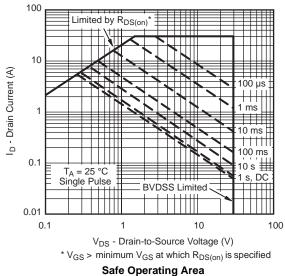


### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Single Pulse Power, Junction-to-Ambient








