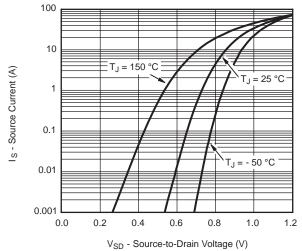






#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted

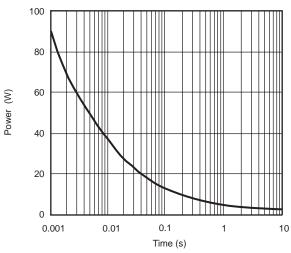


#### Source-Drain Diode Forward Voltage

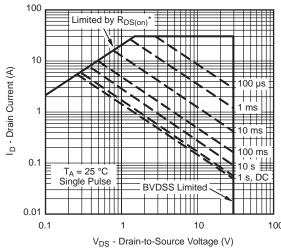

Single Pulse Power, Junction-to-Ambient







Power Derating, Junction-to-Ambient

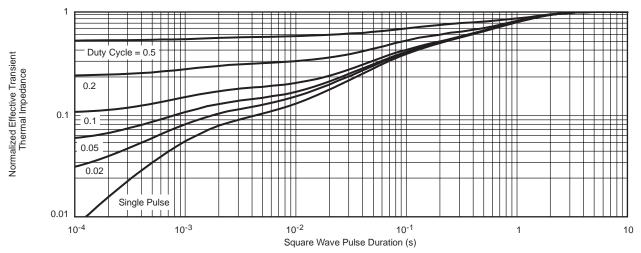

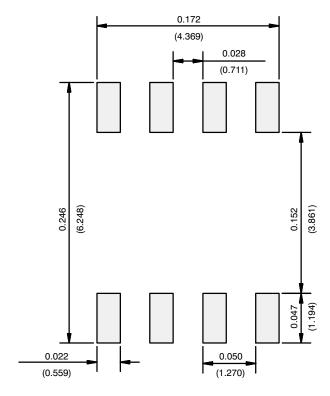
