
#### TYPICAL CHARACTERISTICS 25 C, unless otherwise noted




T<sub>J</sub> - Junction Temperature (°C) On-Resistance vs. Junction Temperature






#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted






Single Pulse Power, Junction-to-Ambient







#### TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Normalized Thermal Transient Impedance, Junction-to-Foot


