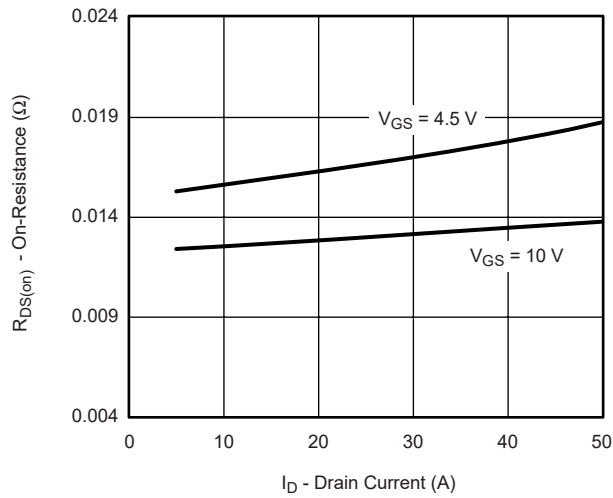

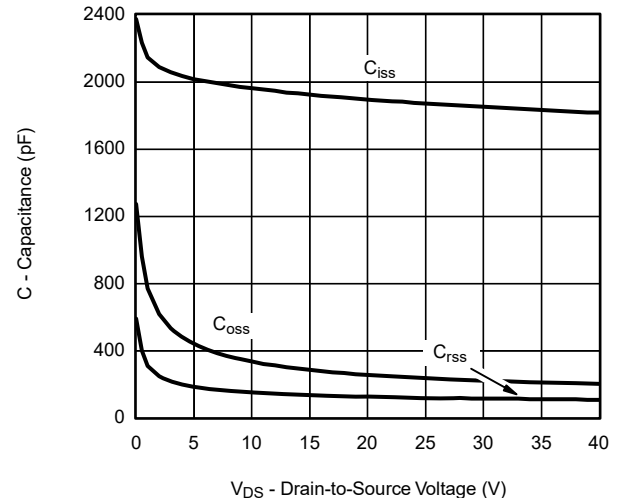

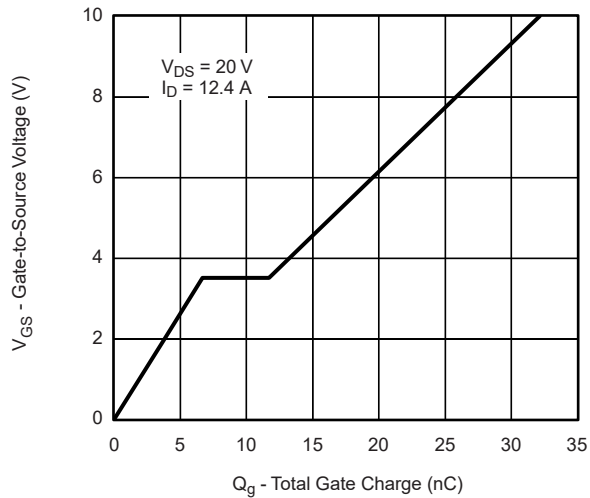

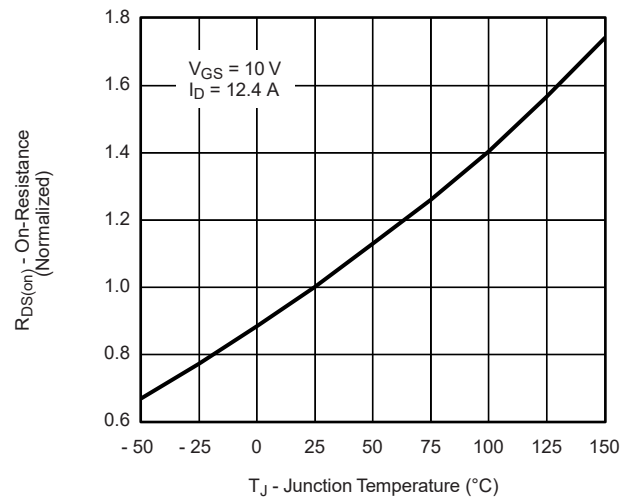
On-Resistance vs. Drain Current and Gate Voltage

Gate Charge

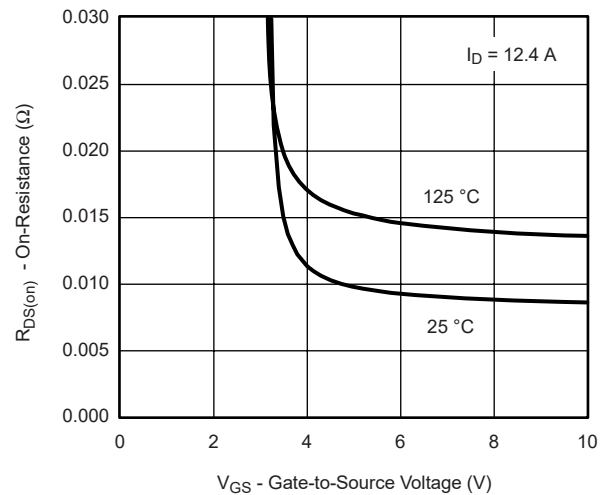


On-Resistance vs. Junction Temperature

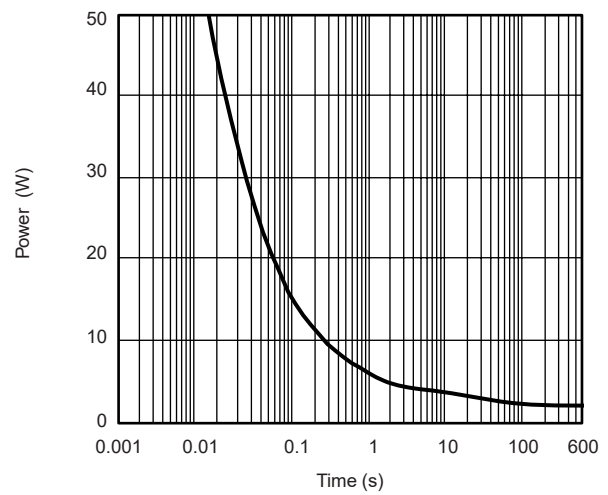
Source-Drain Diode Forward Voltage

Threshold Voltage



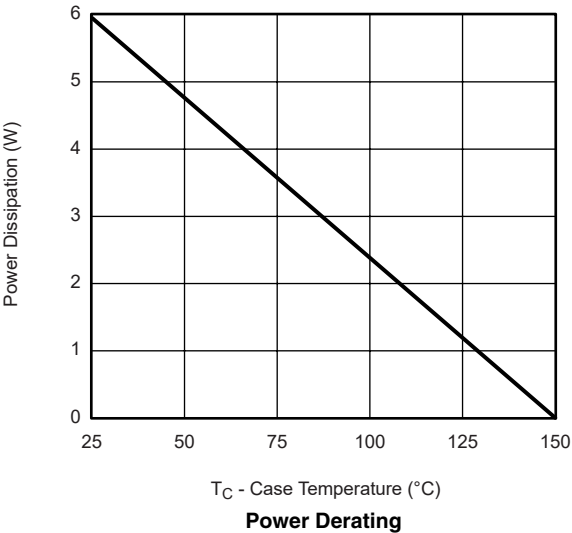
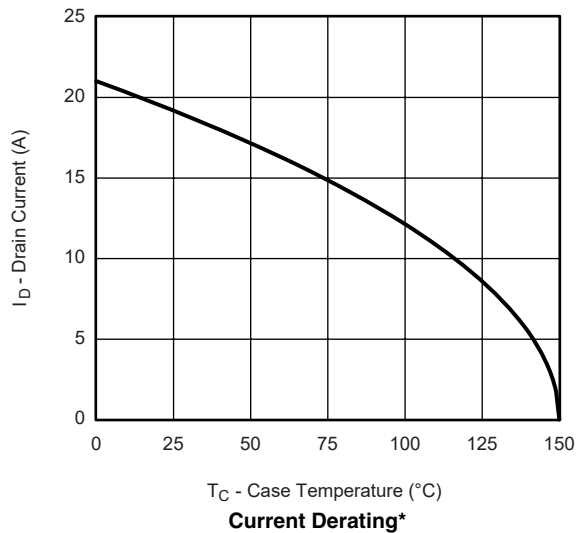
Single Pulse Power (Junction-to-Ambient)

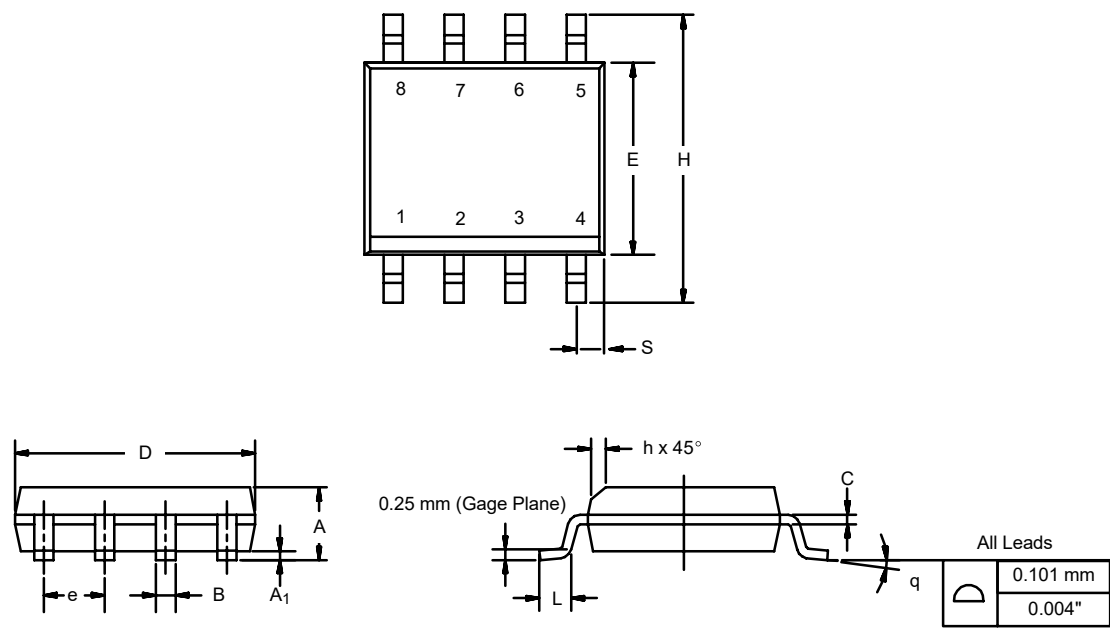

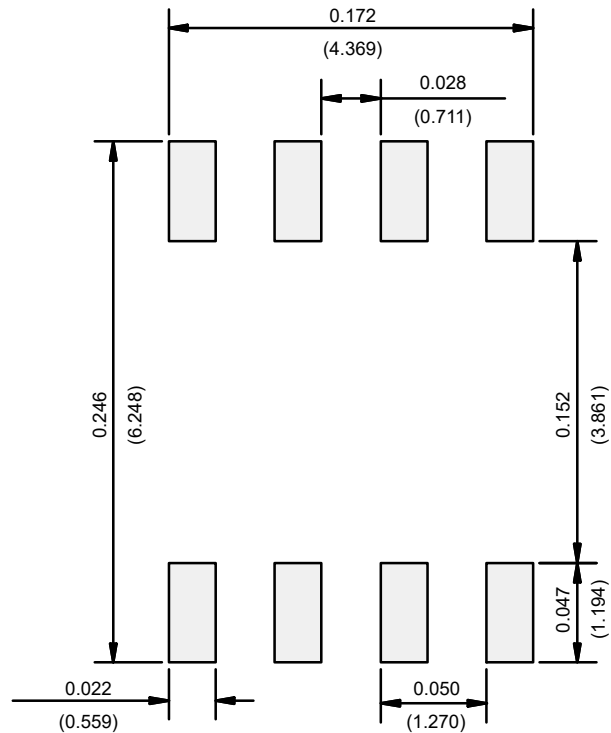
