











Source-Drain Diode Forward Voltage




V_{GS} - Gate-to-Source Voltage (V)

Single Pulse Power, Junction-to-Ambient










Current Derating*



Power, Junction-to-Foot





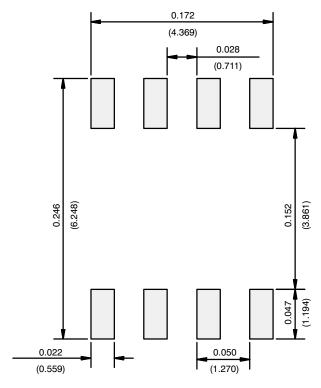
