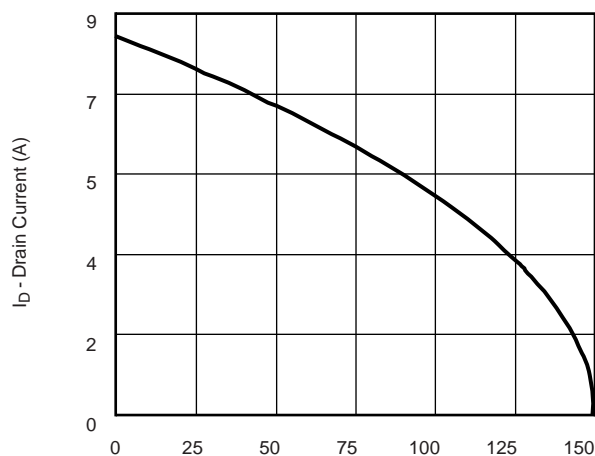

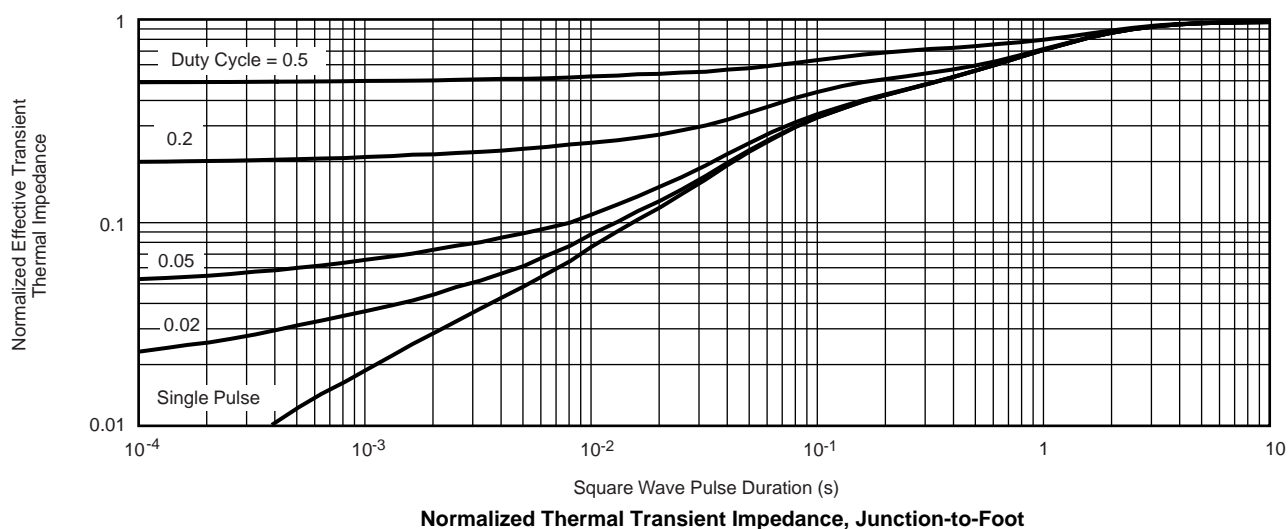


$T_C$  - Case Temperature (°C)

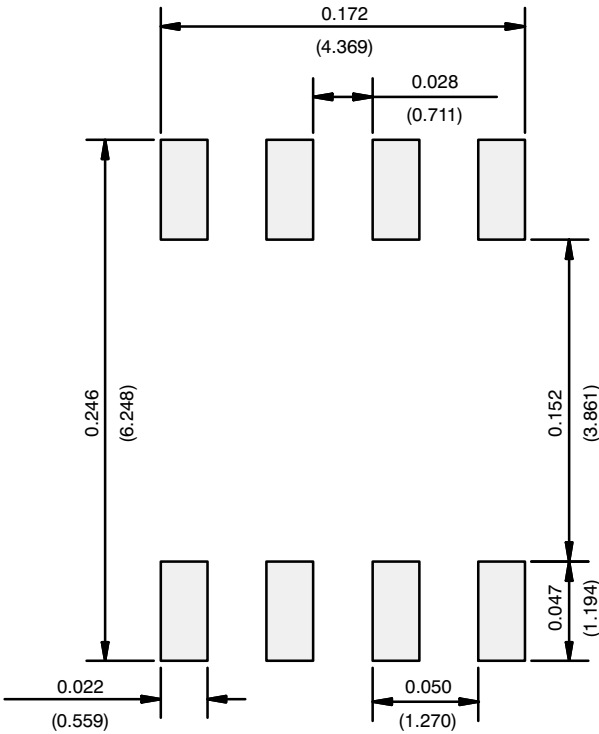
