





 $\label{eq:loss_loss} I_D \text{ - Drain Current (A)}$  On-Resistance vs. Drain Current and Gate Voltage







V<sub>DS</sub> - Drain-to-Source Voltage (V)




On-Resistance vs. Junction Temperature




On-Resistance vs. Gate-to-Source Voltage



**Threshold Voltage** 



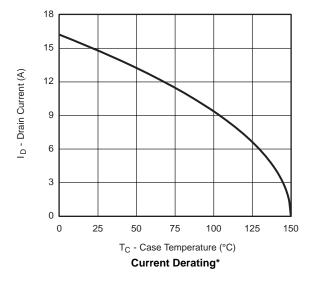






Safe Operating Area, Junction-to-Ambient





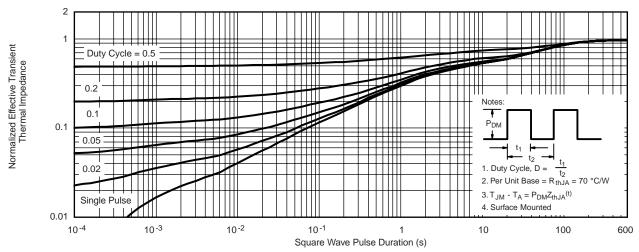




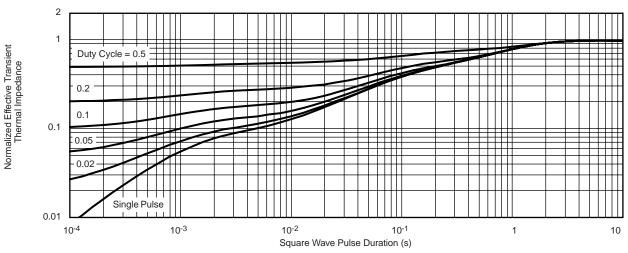

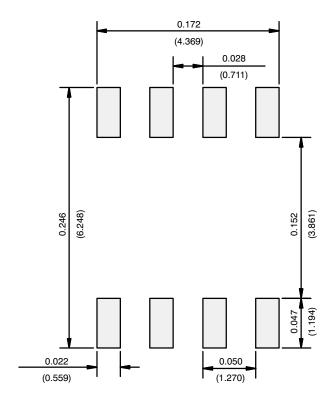
