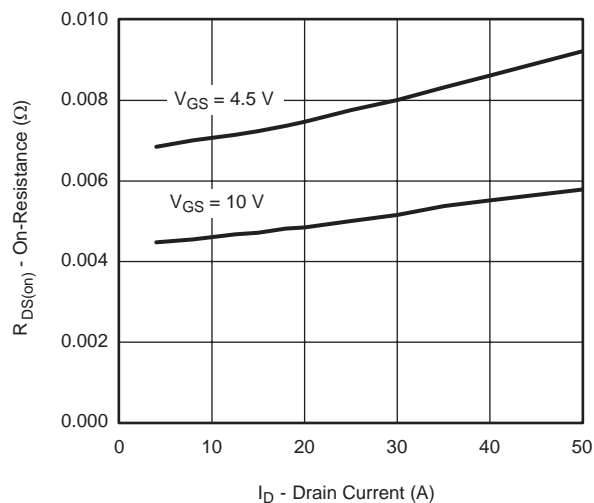

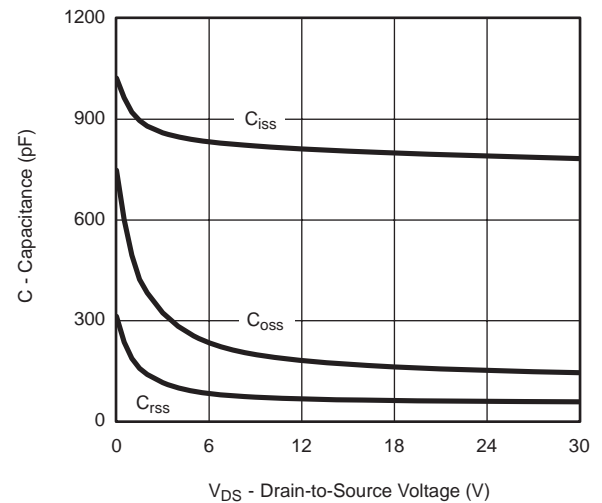

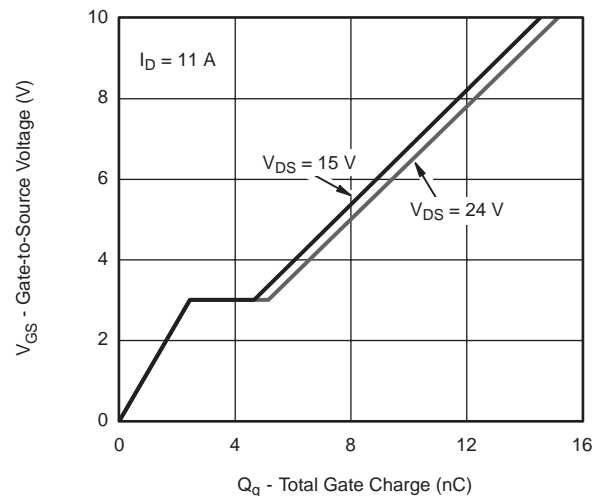
**Transfer Characteristics**



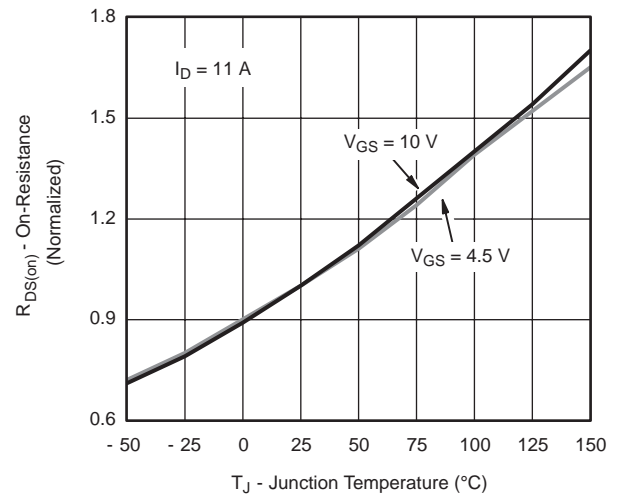
**On-Resistance vs. Drain Current and Gate Voltage**

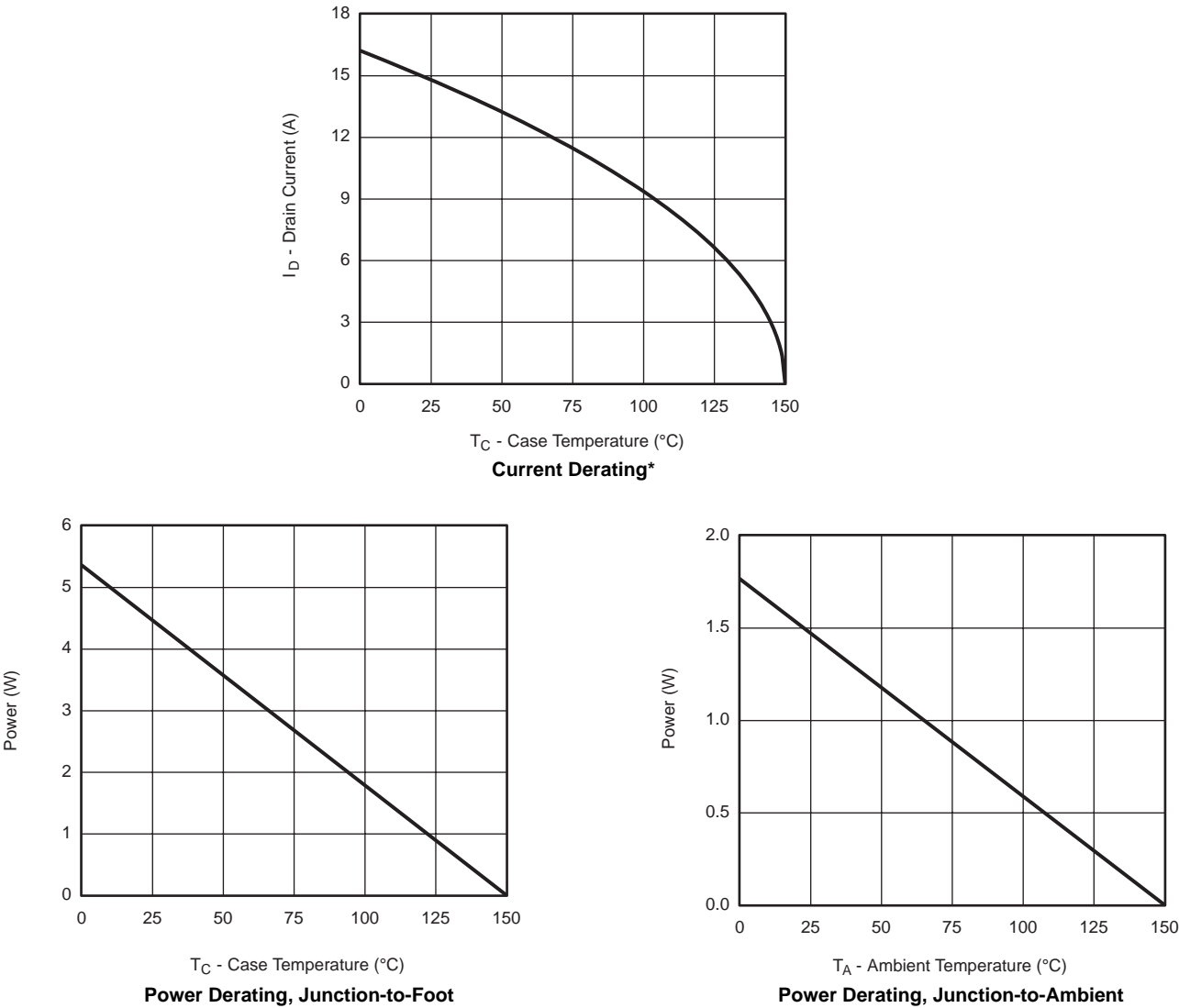

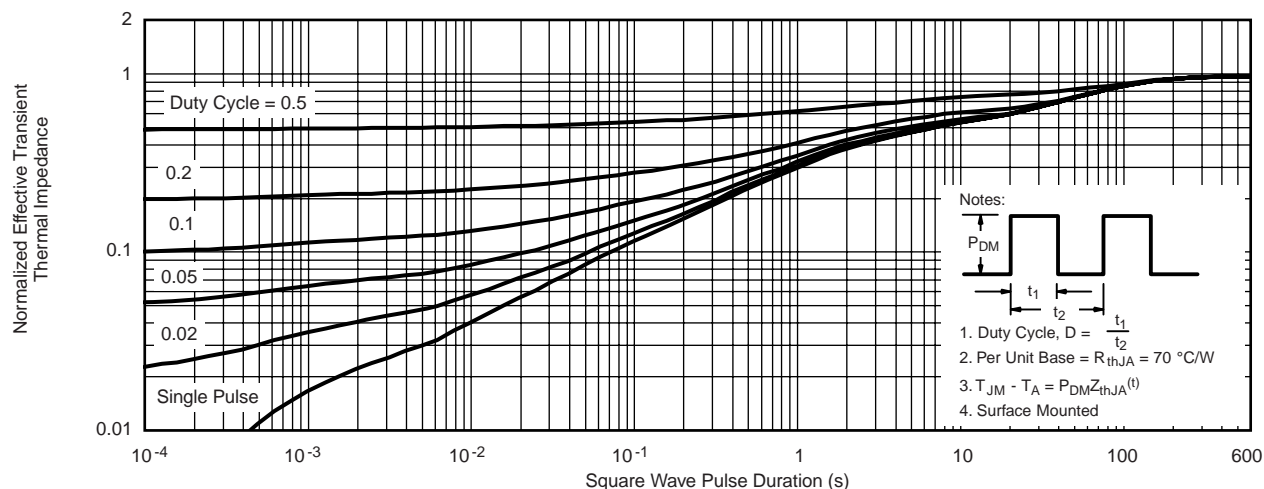
Safe Operating Area, Junction-to-Ambient

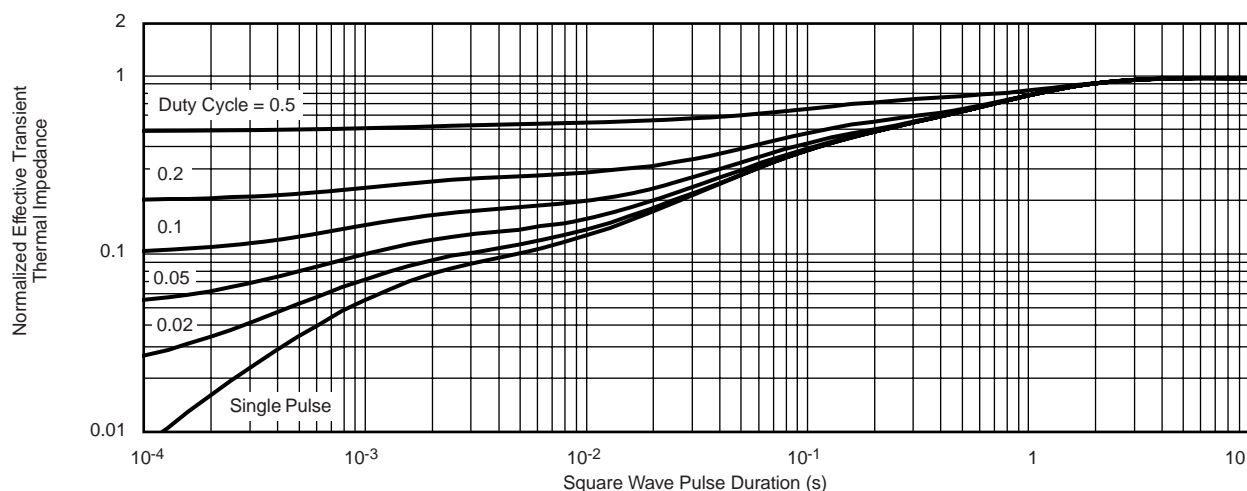
