



> $\mathbf{Q}_{g}$  - Total Gate Charge (nC)  $\mathbf{Gate\ Charge}$



On-Resistance vs. Junction Temperature











V<sub>GS</sub> - Gate-to-Source Voltage (V)


### Source-Drain Diode Forward Voltage



### On-Resistance vs. Gate-to-Source Voltage










Safe Operating Area, Junction-to-Ambient













