






TYPICAL CHARACTERISTICS 25 C, unless otherwise noted






TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Source-Drain Diode Forward Voltage



Single Pulse Power, Junction-to-Ambient

















T_A - Ambient Temperature (°C) Power Derating, Junction-to-Ambient



Normalized Thermal Transient Impedance, Junction-to-Ambient





Normalized Thermal Transient Impedance, Junction-to-Foot

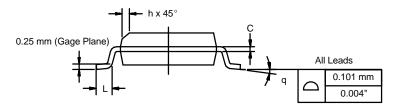


