







TYPICAL CHARACTERISTICS 25 °C, unless otherwise noted




Source-Drain Diode Forward Voltage






On-Resistance vs. Gate-to-Source Voltage



Single Pulse Power, Junction-to-Ambient







T_A - Ambient Temperature (°C)


