











Source-Drain Diode Forward Voltage





Single Pulse Power, Junction-to-Ambient















Power, Junction-to-Foot





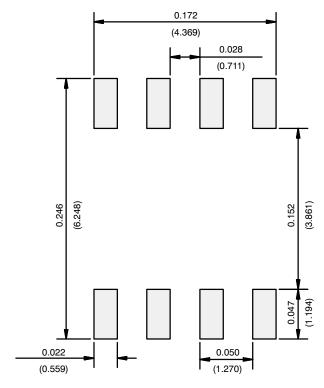
